YFT UPDATE

The start of each school year should be viewed as a new beginning, a new opportunity, a new chance to provide our students with the very best educational environment possible. However, with over two hundred of our colleagues still on a recall list, it is hard to look at this September as a time for a fresh start. The number of teachers and teaching assistants taken from our classrooms is so large that funding for their return can only come from the state and federal governments.

AFT and NYSUT continue to assist us in our outreach to both those levels of government. On Monday, September 26th, Yonkers will be targeted as the start of a statewide campaign highlighting the effects the massive cuts to education have caused. Then, a press conference on September 26 will be followed by an evening round table discussion open to the public on a date to be announced.

While we will continue the fight to return our members, please do not be misguided by claims that teachers were not open to helping the district. The teachers agreed to a \$2.5 million savings cut to the district this school year by deferring payments owed as a result of the salary step arbitration. Another agreement concerning scheduling saved the district over \$3 million. Through our political action persistence, we were able to convince the City Council to include an additional \$5 million in reoccurring funds in the budget. Through the Federation's efforts we have secured close to \$11 million for the district.

A lie told often enough begins to seem like the truth. Unfortunately, the media continues to falsely report that the teachers did nothing whereas they should be asking when the schools will be adequately funded. When will the teachers no longer be the whipping post for Yonkers City Hall's refusal to do its job and secure proper funding for our schools?

At the same time, the district continues to attack our posting, transfer and seniority rights. This year, on the very first day of school, the district pit elementary teacher against elementary teacher by engaging a select few in position "swaps", at the discretion of the principal, completely circumventing seniority and the contractual transfer procedures. As with the other 30+ grievances, arbitrations, and PERB (Public Employment Relations Board) cases, it takes time to resolve, but it will not be ignored.

Recently, a new law was passed concerning teacher and principal evaluations. In the law it clearly states that, until there is a new contract, no new evaluation system can replace the current system. The YFT negotiating team has identified several members to begin discussions with the district regarding our evaluations, including a new Annual Professional Performance Review (APPR). State tests cannot be used in our present evaluations until a new contract has been negotiated which includes a new evaluation process.

Remember, no administrator can use state tests in your evaluations. If any administrator tries to do so, please report this to your building representative at once. If any observation speaks to test scores, it is a serious violation and the YFT office must be informed. Although the Federation has requested dates for negotiations, sadly, the district has not agreed to meet at this time. You can certainly understand how that impedes progress on multiple levels.

New Teacher Evaluations

Teachers have questions and we have answers.

Am I going to be evaluated based on my students' performance on state tests?

Yes. However, only 20% of your evaluation must be based on standardized tests.

I had heard that it was going to be 40% based on standardized tests. When did that change?

NYSUT brought a legal action in State Supreme Court to have the newly promulgated regulations changed to correctly reflect the new state law regarding teacher evaluations. Last month the judge ruled that NYSUT was correct and that only 20 % of our evaluations had to be based on student standardized test scores.

Is the new evaluation system going to begin this school year?

No. Not unless it is negotiated with and agreed to by the YFT. We have a contract in place. Although the ending date of our contract has passed, the Triborough Amendment to the Taylor (NYS Collective Bargaining Law) allows our contract to continue in full force unless and until a new contract is negotiated and ratified by the YFT membership and the District.

How will I be evaluated this year?

You will be evaluated according to the terms of the present APPR which was originally negotiated in the year 2000.

What does APPR mean?

The letters stand for Annual Professional Performance Review and it is negotiated by each school district and their teachers' union. It must contain specific things. For example, there are mandated criteria for evaluation and there is a mandatory support plan procedure. The exact way these are used to evaluate teachers is a mandatory subject of bargaining in the state of New York.

What if I am told that there will be a new kind of evaluation of teachers in my school?

Call the union office. Tell your Building Rep. Only through collective bargaining can a new evaluation system be put in place.

Are you sure it is only 20% based on student test scores?

It is 20% based on standardized test scores, and then 20% based on student performance indicators or local measures that are negotiated. It is 60% based on other criteria similar to what we have now that will be negotiated.

If you would like to send any evaluation suggestions to the negotiations team, please send them to the union office, to the attention of the YFT Education Issues Committee.

You will be kept informed as to the progress of negotiations once they begin.

Friends of the Cambodian Child's Dream Organization

Last year, Kirk Bauer and his students at Riverside High School worked with Friends of the Cambodian Child's Dream Organization (Friends of CCDO), a non-profit, non-political organization dedicated



to improving health, life expectancy and living conditions, by supplying such necessities as clean water wells and toilets, and improving education in the community by supplying uniforms, shoes, book bags and school supplies to allow poor children to attend schools. As a result of a presentation made by Jenni Lipa, President of Friends of CCDO, where students learned about the history and culture of Cambodia and gained awareness of genocide and the need for tolerance worldwide, students developed an interest in helping the Cambodian villagers and orphans. Some students even fulfilled their community service requirement by selling leather craft Cut-Outs made by the children at the Little Angels Orphanage. In addition to benefiting the children who make the Cut-Outs, money raised from the sales was used to build two water wells for Cambodian villagers.



This summer, we were fortunate enough to travel to Cambodia to see the two water wells donated by the Riverside H.S. students, as well as another water well we donated last August after returning from our first trip to Cambodia. Although we had seen photos of the wells and a few of the people who benefit by

them, seeing them in person, in context, and meeting some of the actual people was extremely moving. To think that our small donations had such an impact on people's lives was inspiring. We saw firsthand

and heard from the families how the water wells had improved their lives for themselves, their children and other members of their village by providing clean, safe water.



After visiting the water wells, we also visited the Little Angels Orphanage and delivered educational supplies to children in two schools (Phum Steung & TaPang). At the orphanage we met friendly, hardworking children who demonstrated their many



talents and skills for us: designing and crafting leather carvings and performing a hilarious shadow puppet show. At the schools, students recited their

English lessons for us and sang in English such songs as "Rain, Rain, Go Away," "Head, Shoulders, Knees and Toes," and "You Are My Sunshine." The children, who ranged in age from 7 to 15, were enthusiastic, friendly and showed a great interest in learning English. Kara, an ESL teacher, had the

opportunity to lead them through a mini-lesson using the popular American children's book by Bill Martin and Eric Carle, "Brown Bear, Brown Bear, What Do You See?" and also introduced them to two new songs, "The Itsy-Bitsy Spider" and "I'm a Little Teapot." In all, it was truly a memorable, amazing day.



Each decade since the 1940's there has been a major genocide somewhere in the world. It is the hope of Friends of CCDO that the lessons learned from the genocide in Cambodia can help foster tolerance among our youth. Attention: You Must Rejoin the Union and the Welfare Fund...

If you went out on a Family Medical Leave Act (FMLA) or any other leave (including those members who were laid-off and subsequently rehired), upon your return to your assignment you must rejoin the union (including NYSUT) and the Welfare Fund by resubmitting the required forms for membership: NYSUT Membership Form, Welfare Fund Benefit Card(s), YFT Membership Dues Deduction Card and VOTE/COPE Form. This also pertains to any individual who was a full time administrative intern and has returned to teaching.

Teachers who undergo changes in marital status (through marriage, divorce or death of a spouse), or addition of children, changes in beneficiaries or residence and/or phone number *must notify the Welfare Fund*.

If you need further information please call us at 914-793-0393 and ask for Georgia DeMuro or Kathy Reagan. All claim forms can be obtained on-line at the YFT website, yftonline.org.

I M P O R T A N T INFORMATION FOR YFT MEMBERS:

Unlike the School District's basic health plan, the Fund covers supplemental benefits only. This includes dental, vision and co-pay reimbursements, which are not subject to the Federal Patient Protection and Affordable Care Act, and thus, the Fund does not extend coverage to adult children to age 26. Under the Fund's rules, which remain unchanged, children of members are eligible for benefits if they have not reached their 19th birthday or are under 25 and are full-time students at an accredited educational institution.
