Dear Colleagues,

There seems to be some confusion regarding the information about the "Welfare Fund contribution" portion of the informational flyer handed out at the membership meeting on January 4, 2013, titled "YFT Contract Summary".

The benefits provided by the YFT Welfare Fund are paid for by the contribution made by the Board for each active teacher and administrator. The amount of the contribution is negotiated between the Board and the YFT. In this new contract, the Board will increase its contribution rate for each teacher by 2% in 2012-2013 and another 2% in 2013-2014. The 2% is not taken from your salary. On page 46 of the 2007-2011 contract you can see the amount contributed by the Board for each year, for each active Welfare Fund member. Remember, Principals, Assistant Principals and Central Office Administrators are also members of the YFT Welfare Fund.



UNION DISTRIBUTES FREE STORYBOOKS TO KINDERGARTEN AND FIRST GRADERS

PROBATING A DECEDENT'S ESTATE

The death of a family member or friend is an emotionally challenging event that we will all experience. Some of us will be faced with the added responsibility of having to distribute the decedent's estate.

If the Decedent had a Last Will and Testament, he is deemed to have passed away 'testate' and the estate must be 'probated' in most instances. If the Decedent passes away without a Last Will and Testament, he is deemed to have passed away 'intestate' and the estate must be 'administered' in most instances.

 $T_{\text{he Decedent's Last Will and}}$ Testament will dictate how the assets are to

be distributed. If there is no Last Will and Testament, New York State law provides a detailed, complex line of 'intestate succession' (ranging from spouse surviving greatto grandchildren) that dictates how the estate is to be distributed.

Either way, the legal process is time sensitive and can be a difficult and daunting task for a layperson. For example, the executor must file an inventory of the Decedent's assets with the Surrogate's Court within six months after death and file an estate tax return within nine months of death. In addition, the executor has a fiduciary duty to protect and manage the Decedent's assets pending distribution to the proper heirs.

Whether you choose to retain counsel or go it alone, here are a few tips to make things go smoother:

 Search the Decedent's house and other places for valuable papers and assets.

- Keep a detailed inventory of all accounts, life insurance policies, death benefits, investment accounts, real property owned and individual assets/effects.
- Keep detailed records and receipts for all income received such as rental income, dividends and pension/social security payments received after the Decedent's death.
- Keep a detailed account of and receipts for all expenses incurred on behalf of the Decedent's estate such as funeral/burial expenses, costs to maintain the Decedent's home and mortgage/rent/insurance payments made after the Decedent's death.
 - Make sure that the Decedent's home is secure, maintained, insured and, as necessary, heated during the winter months.
 - Do not sell, distribute or give away any of the Decedent's belongings/assets until you are given the specific authority and direction to do so by

the Surrogate's Court.

• Discontinue unneeded expenses such as cable TV, telephone and periodical subscriptions.

Probating or administering an estate is a daunting matter that must be performed during a difficult time. It gives the executor/administrator great authority and responsibility. Anyone faced with having to probate an estate should always consult with an attorney prior to doing so. The Legal Plan includes in its coverage an Estates and Administration Benefit and we encourage you to contact the Legal Plan attorney to schedule an appointment to discuss your specific needs and concerns in this regard.
